Programming Principles and Approaches

BANCHTE SHEKHA follows some principles and approaches as outlined below to execute its program smoothly:

- 1. Use of social capital by maintaining effective relationship with national and international organizations, associations and networking entities.
- 2. Promoting empowerment through making poor people aware on their rights and making local government bodies/duty bearer responsive to the rights of the poor people.
- 3. Working together with government agencies, other NGOs and private sectors to avoid duplication and overlapping of resources, and to make the existing services accountable and operational
- 4. Gender equity is stressed as global (crosscutting) perspectives across all programs and organizational operations by changing patriarchal attitude and reducing gender discrimination through community driven initiative.
- 5. Promotion of economic activities based upon viability and environmental sustainability with diversification and packaging of relevant services (e.g. remittance and insurance services).
- 6. Lobbying at different levels on behalf of CBOs (Community based Organizations) to avail public resources and innovating new ideas for optimum use of resources.
- 7. Selectively maintain and develop quality but cost-efficient services through efficient management.
- 8. Participatory planning, monitoring and evaluation involving respective community people to create scope for all people to participate in all steps of program implementation.
- 9. Piloting promising new techniques and approaches in the areas of new crises for development to come (innovativeness).
- 10. Establishing Core Think Tank Group of staff to manage the crisis period arising out of limited fund flow to programs and the organization.

Target people/beneficiary: Poor, destitute, vulnerable, marginalized, hardcore poor, downtrodden, harassed people of the society particularly women and children who are the most sufferers.



PROGRAM HIGHLIGHTS

Project: Social Initiative for Promoting Security and Rights of Women and Girls- (SIPSRWG)

Donor: Manusher Jonn Foundation (MJF), Dhaka

Context/Rationale of the SIPSRWG- project: Like other districts of Bangladesh, Gender based violence especially domestic violence and child marriages are very frequent in Jashore and Narail districts. Chawgacha and Bagherpara Upazilas are highly drug addicted area, where domestic violence and child marriage rate is around 50%. Chawgacha and Narail districts are poverty prone area where divorce, dowry, polygamy rate is high. Given the situation Banchte Shekha is implementing Security and Rights of Women and Girls project at Jashore and Narail districts to change the social norms and behaviour towards gender equality, to reduce Domestic Violence against Women, to reduce child marriage and also providing support for skill development of women beneficiaries for raising their income which ultimately reduces economic dependency on men. Women, Girls and children are the main beneficiaries of the project. To reduce violence against women and girls and to facilitate a gender friendly environment, BS is also working with men and boys.




- To increase awareness among women, adolescent and different stakeholders in regards to VAW&G and rights

Qualitative Achievements:

- Targeted women know about their rights and claiming rights not only within families but also going to different service providing institutions for receiving services;
- A large number of men and boys (1404) among the target men and boys (3731) are willingly participating in household works;
- Women beneficiaries are motivated to be engaged in IGA activities to reduce economic dependency on men which ultimately leads to women economic empowerment;
- Most of the women group members are taking part in family level decision making like, higher education of girl child, not to arrange early marriage for girl child.
- Relevant Service providing institutions (Union Parisad, Upazila Women Affairs Office, UNO office, Police, Samaj Seba, Education, Health and DLAC) are attending to the project activities and supportive to provide services to the vulnerable women and girls
- Girls Football Team members are representing national, divisional and local women football team.

Learning due to this intervention (what was situation before and what is improved):

- Rapport building sessions with the disputed parties alongside Salsih are contributing to settle the disputes amicably.
- Strong networking with respective stakeholders absolutely helped in tackling the COVID-19 pandemic situation.
- Group members working as human rights defenders are helping violence survivors through counseling and linking with legal and medical services.
- Family disputes have been reduced through project and local group members' initiative.
- Along with women group leader's adolescent group members are strongly participating to stop and prevent Child marriage.

Challenges:

- Child marriages being arranged in another locality and very secretly;
- Local powerful political guys/ traditional Salishkars are creating barrier to arrange salish at community level
- UP personnel & Police are not much active to prevent and stop child marriage.

16 Days Activism, International Day of the Elimination of Violence Against Women-2020 and Human Rights Day 2020

Theme: "Orange the World: Fund, Respond, Prevent, Collect!'' (Kgjv i‡Oi we‡k¦ bvix, evuavi c_ †`‡eB cvwo).

Because of COVID-19 Pandemic, this year 16 days activism, International Day of the Elimination of Violence Against Women and International Human Rights Day -2020 have been organized in limited and restricted way and duly following government and MJF's instruction in regards to COVID-19

pandemic. There were only arranged rally and discussion meeting with group members, local community people and local project stakeholders keeping gathering/sitting limited within 25-50 persons. There was given importance to remain conscious about Corona Virus and to combat any form of violence against women & girls in collective way through taking social and legal initiatives. All



walks of people across the country are well-known that like the rest world Bangladesh has been badly affected by COVID-19 pandemic. People are losing their job or earnings getting reduced. Same situation exists in the families of our beneficiaries. target Because of the poverty family dispute, rape against women & children, domestic violence incidents against women & girls and child marriage are

happening more rather than that of the previous time. So it has the demand of time to stay beside the COVID-19 affected families and violence survivors through providing need based supports. It may be legal aid or kind/cash support through lobby or strengthening networking with the service providers/duty bearers. To meet the following objectives union and village level awareness raising and message dissemination session arranged in 28 places.

International Day Of The Girl-2020

On 11th October 2020 Banchte Shekha under its Social Initiative for Promoting Security and Rights of Women & Girls has successfully observed International Day of The Girl-2020 at village level. Thinking about the COVID-19 pandemic situation and following the instruction from Manusher Jonno

Foundation (MJF) we observed the program we avoided mass gathering. We have discussed the day's focus with groups' members where there were the representation from the locally men, formed women and adolescents boys and girls. Beyond the village level formed group members there were the Union present local Ward members, Marriage Registrars, Religious leaders. Beside discussion about the negative impacts of child marriage



presents people asked to express their views about the underlying causes for increasing the rape cases against women & minor and adolescent girls across the country and what would be the pathways to get rid of the curse. They spontaneously put their comments and expressed views. Their valuable comments and views have sincerely written down and given a shape.

Dialogue with DLAC and other Service providing government institutions.

A dialogue and Coordination meeting with District Legal Aid Committee (DLAC) and other service providing government institutions (Social welfare, women affairs and UP) and service receiving common people successfully arranged at Jashore & Narail respectively on 4th March, 2021 and 31st

March, 2021. It organized under the banner of SIPSRWG project of Banchte Shekha implementing through financial support from Manusher Jonno Foundation. In the dialogue there were the representation of DLAC offices, Police Administration, District health District Social dept., Services Department Jashore, District Women Affairs Department Jashore, Union Parisad, Media Personnel, Panel Lawyers, NGO, different group members and already benefitted rights holders



under SIPSRWG-project. As honourable Chief Guests there were present District Legal Aid Officer-Jashore and Senior Assistant Judge Md. Ahsan Habib and District Legal Aid Officer-Narail and Senior Assistant Judge Mr. Poshupati Biswas who made the dialogue graceful and successful.



Project Goal: Access to equal right of poor destitute women and children and protect them from violence through legal aid support and awareness raising.

Objectives:

Case Study

New Beginning of Ruma Khatun's Life

Mst. Ruma Khatun was born in a poor family at Churamonkati village, Churamonkati union of Jessore Sadar Upazila under Jessore district. Ruma Khatun was growing as days were passing but family gave her marriage when she was studying in class seven. Because Ruma Khatun father was very poor and he was unable to bear her education expenses.

After marriage they were living peacefully and they are blessed with a baby boy. When their son's age is 4 years, her husband starts saying that, my other brothers

having 2/3 children and I wish to take one more child. But Ruma Khatun not interested to increase number of child. As a result mutiny started in their family. Husband started physically torture her and finding no other Khatun way Ruma agreed to take a child. Meanwhile secretly husband got one more marriage without



informing her and one day he came with new wife at house. After bring new wife at house Ruma Khatun's husband starts physical and mental torturing. One day husband physically torture and chase her out from house.

Ruma Khatun with her 2 children has taken shelter to her father house. She gives formal complaint to Banchte Shekha Legal Aid and Mediation Department. After getting complaint Banchte Shekha Legal Aid and Mediation Department investigates the issue. After investigation, mediation date, time and venue was finalize in consultation with both the parties. During mediation Ruma Khatun's husband confessed his wrongs and seeks pardon to everybody. To mitigate the issue Ruma Khatun's husband gives her 15 decimals land and also gave written statement that, he will never torture her anymore. Husband gives written statement on BDT.150 taka's non-judicial stamp and taken his wife to house along with two children. Now both of them are living peacefully and happy life with children.

Happy and peaceful life on bi-cycle.....

Mst. Achya Akter (Boby) was born in a poor family at Kashipur village, Kashipur union of Jashor Sadar Upazila under Jashore district. At age of 14 years Mst. Achya Akter (Boby) got married. After her marriage physical and mental torture started in her husband house. Husband demanded BDT. 150,000 to her as dowry. But giving the demanded dowry amount was impossible for Achya Akter (Baby) family. As a result torture increased on her for not giving the demanded dowry amount. Meanwhile she becomes mother of one child but torturing on her did not stop. But one day she was chased out from house along with her child after beaten by husband. She was seriously injured and clots of blood were on her entire body. In this situation it was impossible for the poor family to bear all the expenses of her and the child. Finding no other ways Achya Akter started hockary to survive her livings. Using a bi-cycle every day she does hockary and sale cloths in villages. Meanwhile she complaint to

Banchte Shekha Legal Aid and Mediation Department. Banchte Shekha Legal Aid and Mediation Department investigated the issue and finally sits with both the parties to get solve.

During mediation Mst. Achya Akter (Boby) husband confess his wrong doing and gave



written statement on not doing the same mistake in the future in front of honorable members of both the parties and taken her house along with child. In the written statement her husband stated that, he will not torture her, not demand dowry, not beaten her and never chased her out from house. Even husband can't force her to stop business (hockary) and she will keep continue business freely. After completing all the formalities during mediation Mst. Achya Akter (Boby) has been taken to own house by her husband along with child. Now both of them are living peacefully along with their child and happily surviving.




